2. IMPORTANT ITEMS

STRATEGIC UPDATE

GC (Chairperson) reported on the final discussions held on the timing of the NZKC's national events' dates and put the proposal to the meeting as agreed to by the Strategic Committee.

NDS (July school hdays)

Friday, October 19th to Monday, 22nd October, 2018

NZDAC (Labour Wkd)

The meeting approved the proposal subject to it being published in the October Dog World and being sent to all NZKC clubs. Ideally, implementation would start in 2018 unless plausible reasons are set out why this should not happen. If these were provided then the implementation date would be pushed out to 2019. The refreshed calendar of national events would be reviewed after a three year period.

2017 ACOD

A copy of the 2017 ACOD timelines were included in the EC papers for sighting. It was agreed that a workshop would be held at ACOD to discuss the options available to include those put forward by John Green in 2009. This would be followed on the Sunday by a general review of the ACOD workshop at the joint meeting of EC, DOC and AC. It was proposed that the latter meeting could be attended by the Chair of NZDJA.

BREEDERS HALL OF FAME/BREEDER OF MERIT AWARD CRITERIA

As requested PD & Becky Murphy had reviewed the wording applied on the health testing within the criteria.

Current: That the kennel performs the available health tests for the breed and abides by the NZKC Breeders Code of Ethics.

Recommended: That the kennel is proactive in performing appropriate and available health tests for the breed and abides by the NZKC Breeders Code of Ethics.

NZKC SYSTEM OVERVIEW

Graeme Sugden (GS) spoke to his overview which had been circulated in full to some EC members and summarised in the EC papers. Main point was that the Registry is the key and not the accounting system. Discussions have been held with Mercury IT who have confirmed that the Registry can front end the relevant financial transactions to then flow into the accounting system. This will eliminate the current duplication of work. Recommendations:

- 1. **Membership renewal** to be via email with a link to take you into the renewal page that has full DPS capability (i.e. internet and Credit card).
- 2. **Registry entry point for financial information** and then have it downloaded into the accounting system.

- 3. **Accounting system** be upgraded to Sybiz Vision with MYOB Account Right as second choice subject to further evaluation work in respect of the Registry interface. Once finalised a brief business case will be presented to the IT Committee with a possibility the system is cloud based. Likely cost of a move to Sybiz Vision is \$1-2k.
- 4. Payroll no change
- 5. **Credit card charge** -- consideration of a charge for using credit cards as a means of payment i.e. once internet payments are an option for all services

DANGEROUS DOGS - DEPARTMENT OF INTERNAL AFFAIRS (DIA) MEETING

If previous requests both approved an additional judge's panel will need to be established on the NZKC website. 6 current judge's details were provided for the panel once established. It was noted that all must be NZKC members.

26/27 NOVEMBER EC MEETING IN DUNEDIN - FORMAT

A draft plan was set out in the EC papers. EC requested that Southern Ladies KA be approached for the two NZKC presentations (Rebranding & CH&W) to be held at Forrester Park at lunchtimes.

SM noted as apology (ST already lodged).

NT suggested that sub-committees could meet on the Saturday morning.

JUDGES/SHOWS

Jack Boyd (NZKC Life-member) had provided a paper and requested an opportunity to speak to it at the meeting. Consent was granted for 10:30am on Sunday 18th. Some of the same matters had been raised by the NZDJA in their report to this meeting.

- Concern noted on number of championship shows now in place with some only attracting minimal entries. More clubs now staging 4 shows over a weekend. Too easy to attain challenges. Following same path as Australia where number of dogs being exhibited is falling.
- Number of ribbon parades is dwindling used to attract over 100 dogs. Do we have one too many show categories i.e. championship, open and ribbon parades?
- Bias now to Australian judges and practice not being reciprocated. Suggestion a levy be placed on clubs utilising international judges. Furthermore, should Benefit Shows only be able to use NZ judges?

EC agreed that meeting had generated good discussion and highlighted points of contention. PD to send letter of thanks to Jack Boyd.

Jack presented cheque for \$995.60 on behalf of he and Elaine Ingram for monies collected from the weekly parades held at EWEC – money to show as donation for venue.

3. OFFICE REPORTS

DIRECTOR/SECRETARY REPORT

(Matters not reported elsewhere)

- Very good meeting with Trade Me (with BM) on NZKC breeders have standing alone site within Dogs for Sale. They are considering options.
- Meeting held with Gibson Sheat on initial IPONZ response to lodgement of new logos. Nothing of concern and amendments will be made as suggested and relodged.
- Launch of Dogs New Zealand preliminary document being worked on (internal & external)

Objectives

To promote / raise awareness of the change of name to Dogs New Zealand.

To ensure all key stakeholders understand "why" the NZKC is rebranding to Dogs New Zealand and how the new brand better reflects what the organisation does.

To ensure key stakeholders understand the relevant implications of the brand change i.e. what aspects of NZKC will change and what will stay the same.

Reinforcement of what is being launched

NZKC is changing its name to Dogs New Zealand to better reflect the composition of its membership, the activities in which it is involved and its broader interests in the health and welfare of dogs and responsible dog ownership to include domestic dog training and owner education.

TREASURER'S REPORT (GS in attendance)

July & August financial reports were tabled. The net cash surplus to August 31 stood at \$86,981 against a budgeted figure of \$121,857 and a last year figure of \$179,057.

- Legal expenses are well ahead of budget and property valuations @ \$7k are an unbudgeted item.
- Overall income is down against budget (\$4,230 or 0.55%) and expenditure up (\$30, 646 or 4.75%).
- Total cash at 31 August was \$1,446,678 of which \$729,045 was in term deposits. A number of these matured in early August and Westpac were reluctant to provide rates above those published despite amount of funds held with them. GS to investigate other trading bank (3) options. NT to provide GS with a copy of a Treasury policy to be adjusted appropriately and sent to A&R.
- NT questioned why so many bank accounts were held by NZKC. GS responded they
 would not be required under Sybiz Vision where individualised reports/balance
 sheets could be produced and current practice was historical.

CANINE HEALTH & WELFARE OFFICER (Dr. Becky Murphy BM)

- CH&W stall at 2016 NDS. Bulldog/brachycephalic forum being held during NDS as well.
- Other meetings being attended in near future Wairarapa on 12 November and during EC meeting weekend in Dunedin at end of November.
- Representing NZKC at Animal Behaviour & Welfare Consultative Committee meeting on September 14
- Database, Health test results on pedigrees and additional health certificates progressing well.
- NAWAC opinion on selective breeding being peer reviewed by Dr. Joanne Conington of University of Edinburgh. Final draft to be agreed at NAWAC 15 November to then go to Minister for publishing by year end.
- 95 breeders in ABS + 2 from July.
- Labrador LRL scheme featured in September Vetscript.
- Labrador LRL scheme Registration Regulations
 - Draft regulations were tabled. These were approved subject to printing in the November Dog World calling for submissions in time for February, 2017 EC meeting. Looking to introduce on 01.06.17

CLUB & MEMBERSHIP MANAGER (Colleen Begg)

- Buller KA committed to their 11/12 March, 2017 show being held locally given support of local businesses.
- 6 (of 284) clubs have outstanding club subscriptions.
- East Auckland Dog Obedience Club SGM held on 3 August with committee elected and will continue until at least the March, 2017 AGM.
- Canterbury Bull Terrier Club application for second and third championship shows on 18 November, 2017 in conjunction with CKA. Two Bull Terrier judges from the UK are available on that date (judging in Australia).

Dogs on Report:

CH FORTRESS HEAVEN CAN WAIT 06249-2009 - Boxer owned by N & C Jones

The dog has now completed 7 observations without incident and owners have been advised the dog is no longer on report.

KOOLRUNNINGS SHELBY DRIFT'N 01258-2016 – Alaskan Malamute owned by A Hutchby & L Johnson Withdrawn from Huntly KA show due to being in season. Entered in BOI shows on 17/18 September with observers appointed. Club notified.

OAKWAY URBAN ANGEL 02718-2016 - German Shepherd Dog owned by P R & L Halliwell

Complaint received that at Ladies KA's Championship Show on 13 August 2016 the bitch was excused from the ring for aggression towards the judge, Daniel Kwee of Indonesia. He has confirmed that he did excuse the dog from the ring as when he approached to examine her she become aggressive and started to attack him. He says that the handler had good control of the bitch.

KERRYBRENT ISHA LADY LUCK JD 00376-2013 - Border Collie owned by \$ Robertson

Complaint received that at the Fielding DTC's Championship Jumpers Event on 20 August 2016 the bitch acted in an aggressive manner to another dog who was competing in an adjacent ring. Judges from both rings confirmed movement from one ring to the other where she snapped and snarled at the other dog but did not bite, perhaps due to the quick reaction of the owner of that dog. Kerrybrent Isha Lady Luck JD was disqualified from its run. The owner of the dog has been advised by telephone, mail and email that it is on report.

BRIA'S GIRL OB/7835 Springer Spaniel/Heading Dog owned by K Edwards

Complaint received that at the Rotorua Dog Obedience Club's Agility Ribbon Trial on 21 May 2016 Bria's Girl bit a competitor whilst he has attempting to separate her and his dog outside the ring. Reports from witnesses say that Bria's Girl was acting aggressively towards the other dog whilst they were both waiting outside the ring and that she attacked the other dog. The other competitor was bitten on his inner upper thigh and his pants ripped and he required medical attention. Bria's Girl was being handled by the owner's 8 year daughter at the time.

The co-ordinator of the ribbon trial arranged for Chelsea Marriner to talk to K Edwards and her daughter and to come up with a plan to avoid any more incidents with the dog. The complaint was sent to the Agility Committee care of the NZKC after the event. This was forwarded to the Agility Committee who sent it back by email to NZKC on 11 August 2016. K Edwards has been advised by telephone, mail and email that the dog is to be observed. Apology offered for the delay in advising the owner of this. She advised that the dog has taken part in 4 events since the incident on 21 May at the Rotorua Dog Obedience Club. I have contacted all the show secretaries involved asking if there has been any problems with the dog since then and am awaiting replies. Bria's Girl is entered in events on 10 and 11 September and 1 and 2 October 2016 and observers will be appointed and the clubs advised.

 Request from NZDJA to consider ways for up and coming judges to attain experience at ribbon parades and open shows. Two ideas were suggested within the request 1) reinstate requirement for clubs to advise dates of ribbon parades and open shows when applying for championship shows and 2) ribbon parades be scheduled at championship shows during the summer months.

Matter held over for further discussion the following day (Sunday, 18th) as noted elsewhere in the minutes. This will remain on EC agendas for further discussion.

 EC were aware of a dispute between a judge and the NZDJA and elsewhere of some disquiet amongst the NZDJA. It was agreed in the first case that mediation be offered between the parties and that with regard the second matter the NZDJA President and Vice President be invited to the next meeting which is scheduled in Dunedin in November.

MUSEUM TRUST

Report provided by Keith Brown (Chairperson)

- AGM held previous evening i.e. Friday, 16 September. Minutes in next EC papers.
- Looking to make two changes to Trust Deed for greater flexibility in appointment of Trustees.
- Trustees confirmed.
- October Museum Benefit Shows likely to return profit of around \$10k.

Anne McLachlan (Chair) has been on extended leave offshore.

AUCKLAND PROPERTY GROUP

Report provided by Christine Wood (Chairperson)

- High water table in Ardmore causing sewage problems for about 10 houses including APG's house. Short term solution being introduced until summer when it is likely a new system will be installed.
- First two year term is up for the committee. Advert in October Dog World and clubs (10) being written to. Looking to have new committee in place in early November when they will appoint Chair, Deputy Chair, Secretary & Treasurer.
- Need for defibrillator on grounds highlighted during recent incident. To be progressed.

GG noted that MKA also looking to attain defibrillator. PD to contact all clubs to see if there is further interest for bulk purchase. NT may have access through SCDHB.

BW reported all tracking well for competitions at 2016 NDS in ChCh.

6. CLUB MATTERS

MANAWATU KA (dates)

A number of options were presented to the meeting which would look to correct or partially correct the slippage in the calendar which had occurred in 2016. It was agreed to look to change the 2018-2020 calendars as change is imminent at some point with the movement of the 3 National events. The proposed change will be published as part of the National Events article in the October Dog World which is being sent to all NZKC clubs. An amended calendar will be produced for clubs to sight.

HAMILTON KA

A request was tabled for the staging of a 3rd Championship Show in March 2017 which would be judged solely by NZ judges. The show would run in conjunction with the club's other two shows. Whilst EC agreed with the concept and will be considering greater opportunities for NZ judges in the future it could not agree to the request given the concern over the number of shows now on the calendar.

7. REGULATIONS

REGISTRATION REGULATION 9.5.10

Proposed changes to the regulation had been advertised in the August Dog World calling for submissions. The only submission received was from the Canine Health & Welfare Committee who had tabled the original amendments. In effect their submission required that DNA testing (colour) be undertaken and that inspection by judges (3) would only be needed if the DNA results were inconclusive or unavailable. EC agreed with the amendment and in light of no other submissions being received agreed the changes should be implemented immediately.

REGISTRATION REGULATION 10.8.1

A recommendation was received in relation to RR 10.8.1 pertaining to bulldogs and in particular semen registered on the No. 1 Register pertaining to a dog with non-compliant colours. The semen in question was registered prior to the regulation being introduced and therefore any resulting progeny, compliant with the NZKC Breed Standards, are eligible to be placed on the No. 1 or No. 3 Registers. Therefore, the recommendation to not have any resulting progeny placed on those registers was not supported as EC is powerless in this situation. PD to advise the writer accordingly.

8. REGISTRY

REGISTRATION BASED ON COLOUR

Letter received from Luzelle Cockburn questioning the placement of pure bred dogs on the No 2 register due to colour faults and stating that health, not colour, should be the primary concern. Becky Murphy is to respond.

REGISTRATION OF A DOG WITH BLANK GENERATIONS

A non-member from Australia had questioned the validity of the decision by the office not to register an imported dog with an incomplete pedigree. The dog had been registered in Australia. Executive Council upheld the office decision. PD to respond outlining the responsibility of the owner to undertake the research to provide a compliant pedigree if possible.

9. CORRESPONDENCE IN/OUT

- **IN**/Letter from Sheila & Bill Morris thanking NZKC for honour of being accepted into the Breeders Hall of Fame. Letter also being printed in October Dog World.

GENERAL BUSINESS

BENEFIT SHOW PROTOCOLS

This are to be reviewed as it makes more sense to give clubs more than 30 days to provide proof of the application of the profits. A possibility is that this could be lodged at the time of advice of the next year's shows.

SOCIAL MEDIA CODE OF CONDUCT
