DISCUSSION PAPER ON FUTURE STRUCTURE OF DOGS NZ

Director Security to organise a tele-conference with project group comprised of PR, LS, CH and Owen Dance to progress discussion paper presented at November 24/25 meeting.

REVIEW OF EXECUTIVE COUNCIL PROTOCOLS – EXHIBITING UNDER FOLLOW EC MEMBERS

KMcL presented two recommended changes to the EC protocols regarding E.C. members & family members residing at the same address exhibiting under a fellow Councillor at any Dog Show following a number of member submissions with strong opinions on the subject.

After discussion of the two options It was decided to replace the existing protocol EC 15 Councillors Exhibiting Dogs with a new protocol:

Executive Councillors are not permitted to exhibit at any show where a fellow Councillor is judging. This includes all dogs in joint ownership. Dogs owned by family members that the Councillor is not a joint owner may be shown.

Moved BH: Seconded; kMcL – Passed. GC, LS & PR recorded their vote against.

2019 NDS

KB reported on current progress of the 2019 NDS Committee.

Venue Contracts & Show Budget

- Venue Contracts have not yet been completed or signed. ST to work with Marlborough Events Team to complete contractual arrangements and identify any potential venue costs which need to be included in Show Budget.
- Show budget is still a work in progress as Show Treasurer updating budget with Agility
 and Obedience event costs / revenues. Revised show budget to be included in
 March accounts presented to Audit & Risk and included in E.C. documents for April
 meeting.

Show Programme Structure

- KB discussed the proposed event structure which has the Marlborough Sunshine All Breeds Championship show (formerly the Prelude) held concurrently with National Dogs Show.
- The centre of the three rings would have a focus on dog activities for the public as this
 was an important opportunity to teach about the pedigree dog. It would include Dog
 at work displays, Agility & Obedience displays, dancing dogs and Canine Friends Pet
 Therapy events.

Recommended Change to Best In Show Schedule

While those who had attended the 2018 NDS show had enjoyed the new show format which created better show atmosphere (especially for public) and ensured exhibitors stayed to the end for Best in Show there has been much adverse member comment about the new format. KB expressed his concern that such member resistance to the new format would affect expected exhibitor numbers and the financial viability of the 2019 NDS.

It was proposed: That the 2019 NDS revert back to the traditional Best In Show Age Group format.

Moved PR: Seconded; KB - Passed.

The Show Committee was asked to resolve any show schedule issues that could affect public understanding / enjoyment of the event.

Funding Support Proposal

Dogs NZ are to make a formal application to the Rata Foundation for funding support towards the travel and accommodation cost of international and local judges, show stewards and volunteer managers for 2019 National Dogs Show in Blenheim.

2020 NDS VENUE HOST/VENUE APPLICATION

PR updated E.C. verbally on the latest progress. The 2020 working group paper has been sent to the AEC Chair and discussed fully in person. The Ardmore Management Committee has discussed this proposal and a response has been received the day before the EC meeting regarding the requirement for venue upgrades to be able to successfully host the 2020 NDS and general operating issues.

The 2020 NDS working group will submit a full report to the April E.C. meeting on the updated proposal to host the 2020 NDS in Ardmore, Auckland taking into account this feedback which will include an updated budget.

2019 REMITS TO ACOD: CONSTITUTION & ELECTION OF OFFICES

A proposed remit regarding changes to Section V: Constitution and Election of Officers, 20. Constitution (D) (VI) was tabled for discussion.

Motion: That Rule 20 (D) (VI) be amended as follows to provide absolute clarity to the replacement process when an E.C. vacancy occurs.

Amended proposal by GC:

That the text: "In the year of that EC member's election" be replaced with "In the year of the election of the E.C. member causing the vacancy"

PR to review the revised remit.

CHALLENGE TO AUCKLAND PROPERTY RESTRICTIONS

ST reported on a well-attended meeting of Dogs New Zealand members which was held on Wednesday 30 January to discuss the future direction of the Ardmore property.

The view of the meeting was that any future decision on sale of the venue should only be taken when the current zoning restrictions had changed so that the land was available for urban housing development and that change was not expected for the next 30 years.

The immediate focus of the Property Management Committee should be on:

- Challenging the current resource restrictions on use (for dog events only) so that the facility has the opportunity to generate additional venue hire income.
- Upgrade shower, camping area, paddock drainage & kitchen so that facility is fit for use for 2020 National Dog Show.

The above topics were subject of further discussion during the presentation of the Ardmore Management Committee later in the meeting.

2019/2020 E.C. MEETING DATES

It was agreed on the following locations for upcoming E.C. Meetings:

July 27/28 2019: WellingtonSeptember 14/15: Wellington

Locations for meetings in November / February / April 2019-20 were to be confirmed by the new incoming President & E.C.

There was discussion if there should be a formal E.C. meeting on June 21 prior to ACOD or it should be scheduled earlier in the month. This was unresolved and the June 21 meeting remains in the meeting schedule.

There was also discussion on who on the current E.C. is standing for election at 2019 ACOD with LS, CH, SM confirming that they were standing for re-election.

4. OFFICE REPORTS

DIRECTOR/SECRETARY REPORT

1. 2019-020 Business Plan

 Draft 2019-020 Business Plan together with key project plans that will require additional investment will be sent Audit & Risk committee for their comment and feedback before being sent to Executive Council for discussion at April meeting.

2. Key Relationship & Reputation Activities

- Recommend that the E.C. reconsider its decision not to adopt the revised Bulldogs Breed standards presented by CH&W, as it has significant implications for our key relationships and reputation.
- Companion Animal Council key project for 2019 is to establishing a Campaign Animal Behaviour & Training Accreditation Council which could have an impact on our dog training courses offered by our member clubs.
- Recommend that we have a presence at this year's LGC which will be held in Wellington on 7-9 July as developing a closer relationship with Local Government Animal Management teams is an important part of our strategic relationship.

3. Key Revenue Activities

- New sponsorship MOU with Pet n Sur / Interislander to be negotiated to protect and expand existing revenue streams.
- New sponsor leverage strategy being developed with Masterpet to position DogsNZ for renewal negotiations.

4. Staffing

- Recruitment for New Editor / Communications Manager, CH&W Administration support role in March.
- To free the Director Secretary role for a more business development focus I have started to shift the dispute resolution workload to Colleen Barr (Membership Manager) and will be looking to the Admin Support position to take care of the E.C. secretarial work load (which could include minute taking at E.C. meetings).
- To provide more Comms / Strategic Relationship support 12 months retainer for Sunders Unsworth is included in FY019 draft budget.

5. Facilities Issues - Forrester Park

ST will attend Forrester Park Management Committee Meeting in March to discuss
concerns that the building is in breach of current Fire Regulations and the required
remedial work. Also meeting with Dunedin City Council to resolve the removal of an
historic reference registered against the land title for an earlier lease long since
expired and sign a new lease agreement.

Concern was expressed at potential Fire & Safety issues with Forrester Park. Unless there is immediate remedial work undertaken, E.C. to request that the Management Committee close the venue for any public shows. Issue is to be monitored by Health safety Committee.

NT asked that E.C. spend time at the April meeting to review the Bulldog Breed standard decision. The submission papers from members and clubs which were presented to Breeds Standard Committee are to be circulated to E.C.

ST to undertake market review of potential sponsorship partners that can be involved in market negotiations for new naming rights sponsorship.

IT/On-line Show Programme (Sue Conner)

- In March will cut all links to the old NZKC website.
- Rapid progress being made to create one database to collect all health tests from LRL /
 Accredited Breeders so these can be attached to the Online Litter Notification and have
 the full health history viewable with the with dogs pedigree. The standalone Accredited
 Breeders site will be amalgamated into the Dogs NZ Site and accessible through the Canine
 Health tab on our site.
- Weekly news letter to members to keep them informed of upcoming or important information and offers is under development and expected to be live in March.
- The Online Show Programme has now processed over 133,480 enrolments. Working on automating reporting sheets and mail merge templates for Rally-O Qualifying certificates as well as tidying up the catalogue export file so less formatting work is required

TREASURER'S REPORT

Report provided by Graeme Sugden (GS)

- Financial updates for 31 January provided as well as full December financials and draft 2019-20 budget.
- Net cash surplus to 31 January at \$111k against budget \$90k. Monthly surplus was \$32 v budget of \$34k despite unbudgeted Agility expenses of \$10k for a Global Judging programme,
- Successful renegotiation of legal costs with charge for Court of Appeal legal costs been reduced by \$5k.
- There is some risk around sponsorship income with \$15k in dispute which if not resolved will require an adjustment to revenue booked to date,
- Forecast result for year has increased and barring any cost blow outs wil be close to budget for the year.

Concern was expressed by SM at regular un-budgeted Agility spending on equipment and judging expenses and honorariums which is impacting on bottom line. Dogs NZ head office to work closely with new chair of Agility on 2019/20 budget.

NT advised that any discussion on the draft budget should wait until E.C. had received Full Business Plan and Investment proposals. Saturday morning at next E.C. meeting will be set aside to discuss 2019-2020 Business Plan, Investment Plan and implications for draft budget.

ST to look at option for using Corus as Wellington property maintenance contractor as maybe savings in having same contractor as Auckland venue.

CANINE HEALTH & WELFARE OFFICER

Rottweiler LRL

- There have been 3 submissions received regarding the proposed Rottweiler LRL Registration Regulation wording from representatives of the Rottweiler Clubs.
- These have related to 10.14.3, and subsequently the proposed Regulation will be amended. Following from difficulties the office has had with members claiming "clear by parentage" with no DNA proof of parentage, CHWC has also clarified this regulation.

NAWAC

• BM has been invited by NAWAC to meet with them on the 21st May 2019 to present our progress in addressing their Opinion piece on selective breeding and welfare issues. While Dogs NZ are positive that we are well on the way to addressing most of their concerns our decision not to update the Bulldog breed standard to reflect current international kennel club, breed, welfare and veterinarian positions opens us to reputational attack.

Health-testing, website

- There have been significant developments in the capacity for Dogs NZ to receive and store
 health tests in the Registry system. Any litter notified that requires health testing on parents,
 for example the LRLs or ABS, notification will not proceed until all health results have been
 uploaded.
- This will allow us to store health information of each dog in the Registry system. All previous ABS and LRL results have been moved over to the new interface system.

Brachycephalic Working Group

• Two applications have been received for the Bulldog representative position and a recommendation will be made to E.C. after the next CH&W meeting on 8 March.

Breeders Code of Ethics (BCOE)

• The updated table will be published in the March edition of the Dog World calling for submissions.

Mallory LRL Issue

 Request to E.C. to change endorsements on existing Labrador registrations based on findings of latest DNA testing. E.C. have asked Becky Murphy to interpret test results, review the copy of the original export certificate and decide if this should go to CH&W for consideration or is a Registry issue that can be resolved by Director Secretary.

Canterbury Labrador Retriever Club

Mastiff Breeds Association

• Confirmation received from the Mastiff Breeds Association confirming that the Tibetan Mastiff has been added to the list of breeds associated with the club.

Southern Gundog Society 3rd Championship Show 2020

 The Southern Gundog Society has applied for a third championship show for 11 or 12 July 2020. The club wishes to hold the third show in addition to their usual championship shows at Easter and in November.

E.C. declined approval as they do not understand the rationale for the additional show. Also they believe that the overseas judge nominated for show is not suitably qualified. ST (with the help of BH) to write to the Club outlining reasons behind decision.

Otago Kennel Association Change of Show Dates

- Otago Kennel Association originally had the second weekend in July each year for their two championship shows but changed it in 2017 citing the bad weather typical at that time of year. They have tried two different dates in 2017 / 18 and requested another change of dates for February 2019 which was published in NZ Dog World.
- Due to the number of objections from Breed Clubs and individual members the Otago Kennel Association have decided to remain with the March dates previously granted to them in 2017.

Glenmarric Cass A Nova ADX JDX 06353-2013 Labrador Retriever owned by L Todd

This dog has been observed at 6 events and all observers have reported that there have been no problems inside or outside the ring. The owner has been advised that the dog is no longer required to be observed.

CH Osuno Magic Mambo 01635-2015 Swedish Vallhund owned by P Harris

This male Swedish Vallhund has now completed the required observations and the owner advised.

GR CH Waterlea 'S Mad About The Boy 02930-2016 Bullmastiff owned by V & W Mills

This male Bullmastiff has completed 7 observations and no problems have been reported inside or outside the ring. The owners have been advised that the dog no longer needs to be observed.

NZ CH Sukunimi's Antipodean Kiwi (Imp-UK) Finnish Spitz owned by T Andrews

This male Finnish Spitz has completed 6 observations without any problems being reported by any of the observers inside or outside the ring. The owner has been advised that there is no need for the dog to be observed at future shows.

This male Alaskan Malamute was excluded from the ring at South Taranaki Kennel Centre's Championship Show on 25 November 2018 for lunging and biting the judge, Owner has been advised on 27 November 2018 that the dog has been placed on report and is under observation. The dog has not been entered in any shows since.

Tars Always At The Ready 00396-2018 Hungarian Vizsla owned by V Reid

This male Hungarian Vizsla was excluded from the ring at Waitemata Gundog Club's Championship show on 17 November by the judge for aggressive behaviour towards other dogs. The owner was advised on 26 November 2018 by mail and email that the dog is under observation.

- Successful members meeting on 30 January to provide members with update on site consents and future impact of Auckland Unitary Plan
- Under the current Unitary Plan any re-zoning of the Ardmore site to residential is at least 30 years away. If we were to sell now we would be restricted to who we can sell to.
- There is a range of existing consents that allow continued improvement work on the property.
- Immediate key project work includes:
 - Waste Water Toilet upgrade
 - o Insulation of rental property
 - Parking Pad upgrade
 - Upgrade of floors & lightening
- Future "bucket list" project proposals include:
 - o Dogs NZ Head Office
 - Purchase adjoining Herring Property

Meeting joined by 3 Committee members Ray Geer, Christine Wood & Gail Meredith who spoke to their report. They emphasised the need to start the waste water and effluent project work this year. E.C. would like to see an emphasis on driving film work revenue (Dogs NZ Head Office to provide marketing support) and to start investigation of work required to change existing consent of use.
